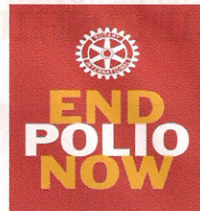


ROTARY IS A NOT-FOR-PROFIT SERVICE CLUB

MEMBER RESPONSIBILITIES

Weekly Programs

Each week a designated member is responsible to provide the meeting program via a presentation that they provide or through scheduling and hosting a guest speaker. A program schedule is published so that each member can plan their programs a year in advance.

Members are encouraged to bring guests to Rotary Meetings – this can be family, friends, or business associates. Luncheon fees are the responsibility of the host or visiting guest and are the same as members.
